OFFICIAL REGULATION OF THE CONTEST

Contest Period: April 18, 2024, to April 25, 2024

Section I. Organizer of the Contest 1.1. The organizer of the contest (hereinafter referred to as "the Contest") is YOUTH ESSENTIALS S.R.L., a legal entity of Romanian nationality with its headquarters at Drumul Regimentului, No. 40, Room 4, Sector 1, Bucharest, registered with the Trade Register under J40/16528/2020, Fiscal Code RO43397614, legally represented by Gabriela Besciu as Administrator, hereinafter referred to as the Beneficiary.

2.1. This Contest is conducted in accordance with the legal provisions contained in Government Ordinance No. 99/2000 regarding the marketing of products and market services, updated, and aims to promote and increase the sales volume of the products marketed by the Organizer.

Section II. Legal Basis. Purpose 2.1. Section III. Area and Duration of the Contest 3.1. Section IV. Right to Participate 4.1. - 5.2. Comments made until April 25, 2024, will be considered validly registered in the Contest. After this date, entries will not be considered. Entries containing indecent language, obscene and/or licentious expressions that do not comply with the requirement described in this Official Regulation will be canceled. The Organizer reserves the right to cancel any entry that does not comply with the provisions of this Official Regulation.

Section VI. Designation of Winners and Awarding of Products 6.1. All participants who cumulatively meet the participation conditions mentioned above will automatically enter the judging stage. The winners of the prizes will be designated by a committee appointed by the Organizer. 6.2. Section VIII. Personal Data Protection 8.1. Thus, the Organizer commits to maintaining the confidentiality of the personal data of the Participants in this Contest and to use it in accordance with this Official Regulation and the applicable legislation. 8.2. The collected personal data, namely the first and last name, age, locality, plus the email address used for registration in the Contest, the first and last name, phone number, and address of the winners will be collected and used for the purpose shown in Section II of this Official Regulation, namely the registration of participants in the Contest and the awarding of prizes, as well as for marketing purposes. The Organizer may disclose the personal data provided by Participants to public authorities upon their express and written request or in case there are suspicions of committing a crime. 8.6. Under legal provisions, you benefit from the following rights regarding your personal data: The right to access personal data and to request a copy thereof; The right to request the rectification or completion of inaccurate or incomplete personal data; The right to request the deletion of personal data processed that concerns you, as far as possible and in accordance with applicable laws; The right to withdraw, at any time, the consent given for this processing, without affecting the legality of the processing before the date of withdrawal; The right to obtain the restriction of processing in case the accuracy of the processed data is contested or the legality of the processing; The right not to be subject to a decision based solely on automated processing (profile creation); The right to receive the data provided or observed in a structured format and to request their direct transfer to another operator; The right to file a complaint with the National Authority for the Supervision of Personal Data Processing. 8.8. Section IX. Litigation 9.1. Any disputes that arise between the Organizer and the Participants in this Contest will be resolved amicably or, if this is not possible, the disputes will be settled by the competent courts at the Organizer's headquarters.

Section X. Miscellaneous 10.1. The Organizer does not assume responsibility and cannot be involved in any way in disputes concerning the ownership rights over the Prizes. 10.2. The Organizer of the Contest is not responsible for the payment of taxes or other financial obligations related to the Prizes offered, these being the responsibility of the winning individuals. 10.3. If the Organizer finds that a winner has not met and/or has not complied
